In pursuance of Letter No.IIE-63/2022/2008/OSSSC dtd. 07.12.2022 of Odisha Sub-Ordinate Staff Selection Commission, Bhubaneswar and as per the results of the recruitment for the post of "Assistant Revenue Inspector under CRE-2021" published vide Notification No. 1904/OSSSC dtd. 06.12.2022 of OSSSC, the following candidates are hereby temporarily appointed under Khordha District Revenue Administration in the post of "Assistant Revenue Inspector" under ODRS (Method of Recruitment & Conditions of Service) Rules, 1983 and posted as such, in the Offices mentioned against their name in the Pay Scale of Rs.19900/- to Rs.63200/- under Level-4 of Pay Matrix under ORSP Rules- 2017 with usual DA and other allowances as admissible from time to time. They shall be enrolled under New Pension Scheme.

The appointment is purely temporary and terminable at any time without notice of assigning any reason thereof.

1. They should join in the post within seven (07) days from the date of issue of this order, in the office mentioned against each, failing which their appointment stand automatically cancelled and they will not claim for any further appointment in this establishment.
2. Candidates are required to produce the following documents at the time of joining.
 - a. Medical Certificate of fitness from a government registered medical practitioner not below the rank of an assistant surgeon.
 - b. Copy of HSC, CHSE or equivalent Education Qualification Certificate showing the date of birth must be submitted and other Higher Educational Qualification Certificate.
 - c. Two character certificates issued by gazetted officers.
 - d. Copy of Identity Proof of candidate.
 - e. Copy of residence certificate issued by the Competent Authority.
 - f. Certificate to the effect that he / she has not more than one spouse living in case of married person.
 - g. Caste certificate in original in case of ST, SC & SEBC candidates.
 - h. Oath of allegiance.
 - i. Confirmation of appointment of SC / ST / PWD candidates is subjected to verification of Original Certificate issued by the competent authority.
 - j. Copy of Bank Pass Book & Two nos. self attested Passport size Photo.
 - k. No TA / DA is admissible for joining.


