
Notice for Engagement of Manpower at Field level offices

Applications are invited from retired Government employees for filling up vacancies in the post of 05 nos. of Supervisors and 05 nos. of Junior Assistant (Statistics) by re-engagement for smooth functioning of DSWO and CDPO offices of the Khordha District.

The eligible retired employees may apply within the following terms and conditions for consideration of their engagements per Finance Deptt. OM No. 24533/ Dated 29.09.2022. Applicants should apply to the undersigned by date 22.05.2023 in person or by Registered Post/ Speed post. Any application received beyond the dateline will not be considered.


- 1) The engagement is proposed to be a period of 2year or till regular posting of such base level post whichever is earlier.
- 2) Under no circumstances their engagement will be continued beyond the approved period.
- 3) However, in case of non-filling up of such base level post, their engagement may be extended with the prior approval of the Department.
- 4) The age of concerned employees should be less than 65 years and having good experience with computer knowledge during his service period.
- 5) The concerned employees have no pendency of DP case and Vigilance case.
- 6) For the post of Supervisors, retired employees with past experience in W & CD Deptt, SSEPD Deptt.,PR& DW Depttwill be considered.Preference may be given to women retired employees.
- 7) For the post of SAs, any retired staff having experience of Office work from any department may be considered.However, preference may be given those have skilled with computer knowledge.
- 8) All retired employees should be posted only under the administrative control of DSWO/ CDPO offices where ever vacant to strengthen their working.
- 9) Remuneration @ Rs. 20,000/- &Rs. 10,000/- will be paid to the Supervisors and Junior Assistants (Statistics)per month respectively.
- 10) The engagement is purely temporary and will be terminate the service without assigning any reason thereof.
