For implementation of Backyard Azolla cultivation programme by women under State Plan Scheme for the year 2020-21 in Khordha district, the Chief District Veterinary Officer (CDVO), Khordha invites Tender in sealed cover from the manufacturer/ stockiest/ authorized dealer/ Govt. approved firms/ private individuals for supply of silpauline and other inputs for implementation of the scheme "Support to farmers for Azolla cultivation during the year 2020-21."

The tender alongwith the required documents to be submitted in the sealed cover to the CDVO, Khordha on or before 3rd March, 2021 by IPM through Registered Post or Registered Post/ in person to be dropped in a specified box available with the Agril. Sub Officer (ASO) of this office, which will be opened on the same day at 4 PM in the presence of the undersigned in the presence of the bidder or their representatives.

The sealed envelope should be superscribed with "Tender for Azolla cultivation inputs" and with valid PAN and GST Registration number for supply. The details Technical Specification and Financial bidding form in Annexure-1 and terms and conditions (reference) of tender in Annexure-2 are enclosed. The items will be delivered at Office of Chief District Veterinary Officer, Khordha. The tenderer may quote the price bid for all the inputs required for the purpose.

The absence of tenderer or his representative will not be a bar to open the tender. The undersigned reserve the right to accept/reject/modify/ cancel any or all tender without assigning any reason thereof. As legal disputes (if any) relating to this tender are subject to the jurisdiction in the court of law at Khordha, Odisha only.



TERMS OF REFERENCE

1. The last date of submission of Tender is 3rd March(Wednes Day) at 01.00PM and the same will be opened on 3rd March(Wednes Day) at 04.00 PM in the office chamber of the Chief District Veterinary Officer, Khordha.
2. The manufacturers/ Stockiest/ Authorised dealers/ Govt. approved firms can participate in the tender process for any of the items or all items of the inputs.
3. The intending bidder will have to submit upto date income-tax return and should have upto date GST return.
4. Preference may be given to the supplier / agency that can provide all required inputs as per the decision of the tender opening committee.
5. The tender will be valid for one year from the date of finalization.
6. The bidder or their authorized representatives shall be present at the time of opening of the tender.
7. The interested Agencies/ Firms may download the document from Khordha web portal (<http://khordha.nic.in>)
8. The Chief District Veterinary Officer, Khordha reserves the right to reject to the lowest bid quoted by the Agency/ Firm, if not satisfied with the concerned Agency/ Firm credibility and put to experience or if the qualities of the sample items are not satisfactory.
9. Further, the Chief District Veterinary Officer, Khordha also reserves the right to accept/ reject/ modify/ cancel any or all tender without assigning any reason thereof.
10. An EMD @ 2% of the total cost of input materials should be attached with the bid in the shape of Bank Draft of any nationalized bank payable to Chief District Veterinary Office, Khordha and the same will be returned to the unsuccessful bidders or will be added with the final payment of the successful bidder on supply of the requisite quality and quantity of the items.
11. No communication shall be entertained over telephone, Fax and Email or in person.
12. Any legal dispute shall be finalized in Khordha jurisdiction only.
13. The payment shall be made to the supplying Agency/ Firm after receipt of the items in good condition and exact quantity at the delivery point. No extra freight charges will be paid to the supplying agency/ Firm upto the delivery point.
