

7. Bids received on line shall be technical opened at 11.30Am on Dt. 16/11/2021 in the Office of the undersigned in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the Office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

The bidder should upload their clear scanned copies of valid Contractor's Registration Certificate, Labour License, EPF Registration, GSTIN Update Clearance certificate, PAN CARD, No relation certificate in shape of Affidavit, Affidavit regarding authenticity of document, document avail price preference in case of ST/SC, Contractors with Physical Disabilities and Engineer Contractors to Avail Exemption of EMD and ISD as per OPWD Code.

- 9. All the original documents with On-Line Generated Bid-Submission Confirmation Sheet, The online remittance of EMD and paper cost should be produce to the Executive Officer Jatni Municipality for verification within three days of opening of Bid, Otherwise the tender will be rejected.
