The Block Development Officer, Khordha on behalf of Government of Odisha invites Percentage Rate bids for the work as detailed in table below from eligible contractor registered with the state Government and Contractor of equivalent Grade / Class registered with Central Government / MES / Railway or other licensing Authority for execution of civil works on production of definite proof from the appropriate authority. **The Contractors who wish to tender for two or more works shall submit separate tender for each. Each tender shall have the Bid Identification No., Name & Sl. No. of the work (as per IFB) to which they refer.**

2. Bid documents consisting of plans, specifications, the schedule of quantities and the detail terms & Conditions of of tender/contract & other necessary documents can be seen in all the offices issuing the documents and office of the undersigned during office hours every day except Sunday and Public Holydays till last date and time of receipt of tender papers. Interested bidders may obtain further information at the said address.
3. Bids must be accompanied with copy of the **PAN card, GSTIN & Bid security declaration** as per Works Department Memorandum No.- 5984/W, dt.27.04.2021. The claim towards exemption of E.M.D, if any has to be provided with the bid in the closed cover.
4. The successful bidder quoting less price than the cost of work put to tender, will have to submit the differential cost i.e. (i. Below 5% - No Additional Performance Security required, ii. From 5% & above and below 10% - 50% of (Difference between estimated cost put to tender and Bid Amount) & iii. From 10% and above – 150% of (Difference between estimated cost put to tender and Bid Amount)) as Additional Performance Security deposit in shape of N.S.C / Post Office Savings Bank Account / Post Office Time Deposit Account / Kissan Vikas Patra / Bank Guarantee (BG) pledged in favour of the undersigned within 7 days as per Works Department letter no.- 4559, dt.05.04.2021.
5. E.M.D required: As per Works Department Memorandum No.- 5984/W, dt.27.04.2021, the bidder must upload "Bid Security Declaration" in lieu of furnishing E.M.D at the time of submission of Bid as per format enclosed.

Exemption from E.M.D is permissible as per codal provision of Govt. of Odisha.
6. The Sale & Receipt of the Bid documents shall be from **11.07.22 to 22.07.22** within **11.00 AM to 4.00 P.M.** of all working days. Bid shall be received in all offices where the bids have been notified to be sold.
7. Bid must be dropped in the tender box having identification no.02.
8. Bidding documents requested by mail will be dispatch by registered / speed post on payment of an extra amount of Rs.500/- over the cost of documents. The undersigned will not responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
9. The Bids will be opened **on the dt.25.07.2022 at 3.00 P.M** in the office of the undersigned, in the presence of the bidders or their authorised representative who wish to attend. If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received & opened on the next working day at the same time and venue.
10. Other details can be seen in the bidding documents.
11. The bidders are required to submit necessary affidavit along with the tender paper regarding authentication of documents, exemption of E.M.D (wherever applicable) as per WD order no.- 9414, dt.08.06.2004 & as per DTCN failing which the tender will be liable for rejection. Besides the bid of any contractor whose tender has been rescinded or has abandoned any work within last 5-years will also be liable for rejection. This declaration should also from a part of the affidavit so submitted.
12. GST will be paid extra at the prevailing rate.
13. The bidders are required to submit no relationship certificate in shape of Affidavit, falling which the tender will be liable for rejection.
14. The Authority reserve the right to reject any or all the tenders without assigning any reasons thereof.
