* The sealed quotation must be super scribe on the cover " **QUOTATION FOR VEHICLE" ORF-6122** and addressed to The DI&PRO, Khordha, Near Old Collectorate, Khordha. It should also remain the complete address of the quotationer.

*The earnest money for the quotation is Rs.5,000/- (EMD) in shape of Demand Draft from any Nationalized Bank drawn in favour of D.I. & P.R.O., Khordha to be payable at Khordha to be attached with quotation paper.

*The highest bidder shall be entertained.

*If the highest bidder will show the un willingness then the next lowest shall be entertained and the earnest money of that bidder will be forfeited.

*The eligible bidder to deposit the rest amount in the same day immediately after the auction process is over.

*The vehicle lying at the left side of the office can be inspected during the office hour.

*The participant/ Quotationer /Bidder should submit the self attested xerox copy towards proof of Residential Address as well as proof of Identity with the Bid.

*The quotations received without EMD and beyond the stipulated date & time and incomplete quotations in any respect shall not be taken in to consideration and liable for rejection.

*Apart from that, the successful bidder is required to deposit the GST amount as admissible on the sale value in shape of Treasury Challan and submit the original copy of the Challan before release of the vehicle.

*The vehicle shall not be delivered to the highest bidder until after full payment and compliance with the requisite formalities.

*If he/she fails to deposit the bid amount within the stipulated period, the deposits including the EMD shall be forfeited and negotiation among the other unsuccessful Quotationers/Participants/Bidders will be made.

*Tools and implements will not be delivered to the bidder with the vehicle.

*The successful bidder shall remove the vehicle from the premises of District I&PR Office, Khordha within 07(seven) days from the date of deposit of the full amount of the bid money.

*On failure to remove the vehicle within the stipulated period, Ground Rent @ 1% of the bid money per day or part thereof shall be charged till removal of the vehicle from the site. If the ground rent so charged exceed the sale price deposited, then the quotationer shall case to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent and the vehicle shall become absolute property of the Government.

*Custody or safeguard of the vehicle shall not be the responsibility of the undersigned and therefore claim or complaint on that account shall not be entertained.

*The EMD of the successful participants/Quotationers/Bidders will be adjusted at the time of final payment of the after amount and shall be refunded without any interest to the unsuccessful participants/quotationers/Bidders after completion of the auction sale.
