

The Sealed tenders should reach to District Election Office, Khordha by Registered Post/ Speed post only on or before 01.3.2019 by 2.00 P.M. and it will be opened on the same day at 4.00 P.M. in the Conference Hall of Collectorate, Khordha in presence of members of Purchase Committee and Bidders or their authorized agents .The tender should be submitted in two Bids i.e. (General Bid & Financial Bid). The envelope in which the intending bidders will apply should have subject to the Terms and Conditions attached with the Tender Call Notice.

The Tender Papers along with the details of specification of the articles will be available in the Website www.khordha.nic.in from dated 23.02.2019 to 01.03.2019 and can be downloaded from the website. The bidder who downloads through websites should pay the tender paper cost of Rs.500/- (Rupees Five hundred) only in shape of Bank Draft/Bankers Cheque drawn in favour of the District Election Officer, Khordha payable at Khordha from any nationalize bank along with tender document .

The Earnest Money (EMD Cost) of Rs 3,000/- (Rupees five thousand) only is to be deposited in shape of Bank Draft drawn in favour of the District Election Officer, Khordha payable at Khordha from any nationalized bank along with tender documents. I. **TECHNICAL BID : (Documents to be furnished along with General Bid)**

In support of eligibility, a bidder must submit the EMD & the following documents, original copies or attested copies, as the case may be along with the Technical Bid.

- a. Detailed Profile of the Contractor/ Supplier.
 - b. Form of General bid application/declaration application & check list form duly filed.
 - c. EMD of amount as specified in the schedule of requirement in shape of Demand Draft in favour of District Election Officer., Khordha, payable at Khordha from any nationalized bank, which will be refunded immediately to the unsuccessful bidders after finalization of tender and to the successful bidders after completion of the Task / Job.
 - d. Paper cost on download of Tender from District Website in shape of DD drawn in favour of District Election Officer, Khordha, payable at Khordha from any nationalized bank. The cost of tender paper is not refundable.
 - e. Copy of PAN Card.
 - f. Copy of the Income Tax return for the last 3 years assessment.
 - g. Copy of the up to date Sales Tax/VAT/SGST & CGST clearance certificate and CST (Central Sales Tax) certificate valid up to 31/03/2019.

All the articles should be delivered in full and good conditions & in no case part supply will be accepted. The Successful Unit/Firm should submit VAT/GST Clearance up to 31/03/2019 during time of submission of Invoice Bill with Delivery Challan.
 4. The Supplier should supply the products having specific company logo in each and every item as specified.
 5. If the supplier fails to supply the articles within stipulated period, the order will stands automatically cancelled and the EMD & security money will be forfeited to Government.
 6. The Bidders are to produce Sample of each item for which rate quoted at the time of opening of the Tender paper i.e. **on 1.3.2019 as per specification. If failed to produce sample items at the time of opening of Tender, the District Purchase Committee shall have right to cancel his Tender documents.**




