

TERMS AND CONDITIONS


- 1-The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Registration Contract carriage permit, Proof of up to date tax payment etc. which are mandatory for applying of vehicle.
- 2-The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be experienced in driving passenger vehicle.
- 3-The Driver should well behaved, gentle and obedient in nature.
- 4- A sum of Rs.5000/- shall be deposited by the intending bidders in shape of account Payee Bank Draft drawn in favour of the **Child Development Project Officer, Bhubaneswar (Urban)-I** and submitted along with the tender as security Deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 5-The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
- 6-The vehicle must achieve a fuel efficiency of 17 Kms per litre.
- 7-The details of year of manufacture of the vehicle, registration no., mileage (Kms covered per litre) and name of the driver with Driving License No- and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender
- 8-The Quotation completed in all respect should reach before the under signed on or before 21.04.2022 by 1 P.M. and shall be opened on the same day at 4.00 P.M in the chamber of Sub-Collector, Bhubaneswar in presences of the bidders or their authorised representatives.




