SHORT QUOTATION CALL NOTICE

Sealed quotations in plain paper are invited from the authorised dealers /distributors /Supplier for supply of Veterinary medicine for O/o-C.D.V.O., Khordha. The list of all items with detail specification, eligibility criteria and Quotation term and condition are annexed herewith. The sealed Quotation will be received by speed post/registered post or by hand only on or before dt.14.3.2023 till 1 P.M. and the Quotation will be opened on same day at 2.P.M. in presence of bidders or their authorized representatives in the O/o CDVO, Khordha. The absence of any of the bidders or their representatives will not be a bar to open the quotations received. The quotation received incomplete and after scheduled date and time shall be rejected. The financial Bid for each item should be enclosed separately including GST and other taxes and the items are to be delivered at O/o CDVO Khordha. The undersigned reserves right to reject any or all quotations without assigning any reason thereof .All legal disputes if any relating to the quotation are subject to jurisdiction of court of law of Khordha district.

PREQUALIFICATION FOR QUOTATION:

1. The participating bidder should be an authorised Dealer/Distributor/Supplier having valid drug licence & GST registration.
2. The participating bidder who has been blacklisted by the State Govt./Central govt./any PSU is not eligible to participate in this procurement process through quotation. A declaration for not being backlisted should be submitted.

TERMS AND CONDITIONS OF QUOTATION:

- 1.The quotation should be neatly typewritten without any correction/overwriting & each page of quotation paper should be numbered.
- 2.Supply should be made at the O/o-C.DV.O., Khordha within 07 days after receiving supply order.
3. The bidder should have a valid drug licence & GST registration.
- 4.The bidder should enclose self-attested copy of PAN, copy of valid drug licence, GST Registration certificate and GST clearance for last quarter.
5. The bidder should submit the financial Bid separately for each item inclusive of all taxes in sealed cover.
6. The tax will be charged as per Govt. guideline.
7. The Payment shall be made after delivery of items in proper condition and as per specification through RTGS after submission of bills/vouchers. The bank details of the bidders should be mentioned on the body of bill.
8. Medicines supplied shall not have expiry date less than one year.

9. The rate contract once approved should remain valid for one year from the date of approval.

10. The bidders representative attending the opening of quotation should submit an authorization letter issued by the proprietor.
