- The bid documents can be had from the office of the undersigned i.e. Project Director DRDA, Khordha on payment of cost of tender paper either in cash or bank draft drawn in favour of the undersigned on any schedule bank payable at Khordha. The tender paper cost is non-refundable.
- Bid documents consisting the plans, specifications, the schedule of quantities and the detail terms and conditions of contract and other necessary documents can be seen in all the offices issuing the documents and office of the undersigned during office hours every day except on Sundays and Public Holidays till last date and time of receipt of tender papers. Interested bidders may obtain further information at the said address.
- Bids must be accompanied with copy of the PAN card, GSTIN & Bid Security declaration as per Works Deptt. ltr. No. 5984 dt. 27.04.21. The claim towards exemption of E.M.D, if any has to be provided with the bid in the closed cover.
- The successful bidder quoting less price than the cost of work put to tender, will have to submit the differential cost i.e. (i. Below 5 % - No Additional Performance Security required, ii. From 5% & above and below 10% - 50% of (Difference between estimated cost put to tender and Bid Amount) & iii. From 10% and above - 150% of (Difference between estimated cost put to tender and Bid Amount)) as Additional Performance Security deposit in shape of N.S.C / Post Office Savings Bank Account / Post Office Time Deposit Account / Kissan Vikas Patra / Bank Guarantee (BG) pledged in favour of the undersigned within 7-days as per Works Deptt. letter No. 4559 dt. 05.04.2021.
- E.M.D. required : As per Works Deptt. Memorandum No. 5984 dt. 27.04.2021, the bidder must upload "Bid Security Declaration" in lieu of furnishing EMD at the time of submission of Bid as per format enclosed. Exemption from EMD is permissible as per codal provisions of Govt. of Odisha.
- The Sale & Receipt of the Bid documents shall be from dt 08.12.2021 to 17.12.2021 up to 16.00 Hours Bid shall be received in all offices where the bids have been notified to be sold.
- Bids must be dropped in the tender box having identification no. 01.
- Bidding documents requested by mail will be dispatched by registered / speed post on payment of an extra amount of Rs. 500/- over the cost of documents. The undersigned will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
- The Bids will be opened on the dt. 20.12.2021 at 11.00 Hours in the office of the undersigned, in the presence of the bidders or their authorised representative who wish to attend. If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
- Other details can be seen in the bidding documents.

19. The bidders are required to submit necessary affidavit along with the tender paper regarding authentication of documents, exemption of EMD (wherever applicable) as per WD order No.9414 dt.8.6.2004 & as per DTCN failing which the tender will be liable for rejection. Besides the bid of any contractor whose tender has been rescinded or has abandoned any work within last 5-years will also be liable for rejection. This declaration should also form a part of the affidavit so submitted.

20. GST will be paid extra at the prevailing rate.

23. The bidders are required to submit no relationship certificate in shape of Affidavit, failing which the tender will be liable for rejection.
