In pursuance of selection of candidates by the Odisha Sub-Ordinate Staff Selection Commission communicated vide letter No. IIE-33/577 (C)/OSSSC dt. 18.06.2018 and letter No. IIE-39/2018-734(C)/OSSSC dt. 16.08.2018, the following candidates are provisionally appointed as **Junior Clerk** on Contractual Appointment against the posts created in pursuance of Letter No. 1409/SSEPD, Dtd. 25.02.2017 in the Scale Pay Rs.5,200/- to 20,200/- + G.P.Rs.1900/- P.M. under PB-I as per ORSP rules, 2008. This is in accordance with **Odisha Group -C & Group-D post (Contractual Appointment Rules, 2013)** they are also entitled for annual increase of contractual remuneration as per **GA & PG Deptt. Notification No. 32010/dt. 12.11.2013** basing on their satisfactory performance on completion of each year of contractual service in accordance with Rule-9(3) of the said Rule.

Their contractual services shall be renewed every year basing on their satisfactory performances and can be regularized on completion of 6 years of continuous service.

They are entitled for leave under the provision of the Odisha Leave Rules, 1966.

Besides they shall be enrolled under New Pension Scheme contained under appointment made under Rule-9(1) of the said rule.

The appointment is purely temporary and terminable at any time without notice or assigning any reason thereof.

1. They should join the post latest by **10.09.2018 by 12.00 Noon** at the (Social Security & Empowerment of Persons with Disabilities Section),Collectorate, Khordha failing which their appointment stand automatically cancelled and they will not claim for any further appointment in this establishment.
2. Candidates are required to produce the following documents at the time of joining.
 - a. Medical certificate of fitness from a Government registered Medical Practitioner not below the rank of an Assistant surgeon.
 - b. Attestation form in duplicate along-with two passport size photographs duly attested by a Gazetted Officer.
 - c. Certificate of educational qualification showing the date of birth.
 - d. Two character certificates issued by Gazetted Officers.
 - e. Certificate to the effect that he/she has not more than one spouse living in case of married person.
 - f. Caste certificate in original in case of ST and SC candidates.
 - g. Oath of allegiance.
 - h. Original Aadhaar Card & Voter I.D.Card with xerox
3. Confirmation of appointment of SC and ST candidates is subjected to verification of original Caste Certificate issued by the competent authority.
4. No TA/DA is admissible to join the post.




