Sealed quotations in plain paper are invited from the authorised dealers /distributers dealing with Veterinary Medicines towards supply of 13(Thirteen)no's of veterinary medicines as detailed below to the Chief District Veterinary Officer, Khordha. The quotations should reach this office on or before dt.27.05.2022 by 9.AM. and the same will be opened on same day at 10 AM. in presence of quotationers and the Committee members. Absence of any bidder or representative will not be a bar to open quotation. Quotations received incomplete after scheduled date & time shall be rejected. The undersigned reserves right to reject any or all the quotations without assigning any reason thereof. All legal disputes if any relating to the quotation are subject to jurisdiction of court of law of Khordha district.

PREQUALIFICATION FOR QUOTATION:

1. The participating bidder should be an authorised Dealer/ Distributer having valid drug licence & GST registration.
2. The participating bidder who has been blacklisted by the State Govt./Central govt./any PSU is not eligible to participate in this procurement process through quotation.
3. The bidder should be of Khordha district jurisdiction of Odisha state only.
4. The bidder should have proof of at least 03 years of supplying medicines to any Govt. organisation/corporate hospitals/PSU/Govt. hospital/Dispensaries.

TERMS AND CONDITIONS OF QUOTATION:

1. The quotation should be neatly typewritten without any correction/overwriting & each page of quotation paper should be numbered.
2. Supply should be made at the O/o-C.D.V.O., Khordha within 03 days after receiving supply order.
3. The bidder should have a valid drug licence & GST registration.
4. Authorised dealers/distributers are eligible if they submit authorisation from original manufacturer.
5. The bidder should enclose self-attested copy of PAN, copy of valid drug licence, GST Registration certificate and GST clearance for last quarter, last 03 years of IT Returns.
6. The bidder shall submit their quotation for any one of the item intend to supply from the list of medicines mentioned below inclusive of all taxes
7. The tax will be charged as per Govt. guideline.

8. The Payment shall be made after delivery of items in proper condition and as per specification through RTGS after submission of bills/vouchers. The bank details of the bidders should be mentioned on the body of bill.

9. Medicines supplied shall not have expiry date less than one year.

10. The rate contract once approved should remain valid for one year from the date of approval.


