5. Age limit as on 1/1/22 for General category 21-38 years, 5 years of upper age relaxation for SC/ST/Women Category candidates, 10 years of relaxation for Pwd Candidate.

On completion of 6 years of satisfactory performance of such teaching & non-teaching staff the collector will recommend to the Director,SSEPD,Govt. Of Odisha, BBSR for allocation of increased Grant-in-aid towards payment of salary at the rate applicable to the teaching & non-teaching staff of comparable rank & qualification in govt. schools subject to their possessing qualification.
