Tender Notice

Sealed tenders in plain paper are invited from interested vehicle owner / Travel Agencies/ Tour operators of the district of Khordha for engagement of their diesel operated vehicle on monthly hire basis for the mobile veterinary unit in the block of Chilika of Khordha district during the year 2018-19 with the following specification on or before 8.8.2018.

Vehicle Type

11. The vehicle should be a Bolero/ Marsal/ Tata Sumo/Mahindra Max and having ample space to accommodate medicine and 4/5 officials excluding driver and road worthy.
12. The vehicle should be within 3 years of manufacture and registration and milage should be more than 10 km. per litre of fuel.
13. The vehicle should have valid registration and fitness along with insurance and contact carriage permit and the driver should have an authentic valid driving license.
14. The vehicle will be stationed at each block H.Q.under the administrative control of Block Veterinary Officer.
15. The vehicle will be stickered regarding Mobile Veterinary Unit of specified block and departmental activities as per instruction from time to time.
16. The vehicle can not be taken for any other purpose of passenger carrying/ luggage transport or any other means without the permission of the competent authority.
17. The vehicle can be utilized for any other purposes by BVO/ CDVO/ SDVO concerned for any emergency work of the department.
18. The salary of driver and all repair work either minor or major is the sole responsibility of the vehicle owner.
19. The fuel and lubricants can only be provided within the departmental provisions as and when required .
20. A separate log book will be maintained by the driver for this duty and to be countersigned by BVO each month without which the bill can not be entertained.

Documents to be submitted

10. Valid Registration Certificate in original.
11. Fitness Certificate of the vehicle.
12. Valid Insurance Certificate of the vehicle .
13. Valid Driving license of the driver.
14. Valid contract carriage permit.
15. Proof of upto date tax payment.
16. Agreement by the owner for permanent stickering of the vehicles if engaged.
17. Under taking by the owner not to misuse the vehicle for other purposes other than department work.
18. Offer price for the hiring charges for one month.

The envelope super scribed by "Tender for MVU of Chilika block" with price bid and other documents should reach the undersigned by 8.8.2018 .

The same will be opened on the 9.8.2018 at 1PM before a committee in presence of the bidder.

The undersigned reserves the right to reject any or all the bid papers without assigning any reasons thereof. Canvassing in any form will force to reject the bid .

The selected bidder have to submit one agreement for one year in Non-judicial stamp paper before receipt of engagement orders.

In the event of any dispute that may arise and in case the matter referred to court of law, the competent court within the jurisdiction of Khordha shall have the authority to decide and dispose of the litigation.
