QUOTATION CALL NOTICE

In pursuance of letter No, 7960/W&CD Dated. 10.05.3033 of Government in W&CD Department and read with Notification No. 28226/F Dated. 04.06.2002 of Govt. in Finance Department Odisha the Govt. vehicle bearing No. OR-02-Q-8504 of Bhubaneswar (Rural) ICDS Project is declared as condemned and hereby put for auction sale. The upset price for auction sale of the vehicle is fixed at Rs. 50,000/- (Rupees Fifty Thousand) only. Interested bidder may participate in the tender by submitting the sealed tender papers supporting with earnest money of Rs. 1,000/- in shape of Bank Draft in favour of CDPO, Bhubaneswar (Rural) subject to refund except in case of the highest offer accepted by the authority. The tender papers should be deposited in a sealed cover with required documents/ information in the office of the CDPO, ICDS Project, Bhubaneswar (Rural) by 3.00 P.M of 12th July2022. The tender papers will be opened on 13th July, 2022 at 11.30 PM by the tender committee constituted under the chairmanship of Additional District Magistrate, Khordha in the Office Chamber of the CDPO, Bhubaneswar (Rural). The Collector & District Magistrate, Khordha reserves all the right to approve the proposal of Tender Committee or reject the process and cancel the tender Call Notice at any time without assigning any reason thereof. The detail information in this regard with copy of Registration Certificate Particulars is available in the district website (<https://khordha.nic.in>). The terms and conditions are as follows.

1. The highest offer price shall be approved by the authority.
2. The highest tenderer shall deposit 25% of the amount immediately after the announcement and the rest within 7 days of the approval of the offer.
3. On failure to make payment as aforesaid the deposits (including earnest money) shall be forfeited.
4. The vehicle shall not be delivered until after full payment and compliance with the requisite formalities.
5. Tools, implements and spare parts shall not be delivered with the vehicle.
6. The tenderer / party shall remove the vehicle from the site within 7 days from the date of compliance of all formalities.
7. Custody or safe guard of the vehicle shall be the responsibility of the tenderer / party and no claim or complaint on that account shall be admissible.
8. On failure to remove the vehicle within the time as aforesaid, ground rent at the rate of one percent of the tendered money shall be charged for each day or part of the day till the removal of the vehicle from the site.
9. Where the ground rent so charged exceeds the sale price deposited, the tenderer / party shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Government.
