Quotation received through fax / E-mail will be rejected.

- An affidavit towards authentication of documents, No relation certificate & history of litigation must be attached with the Quotation.
- The work should be completed within 15 days of receipt of work order
- If there is any discrepancy regarding specification than it will be returned at your own cost.
- The Bills are to be furnished by the supplier in triplicate along with the necessary documents
- The supplier should furnish the valid and up to date ITCC & GSTIN to the paying authority.
- Physical verification of the items will be taken up by the State laboratory Assistant immediately during refilling of the cylinder and defect found, if any will be intimated to the supplier within 15(fifteen) days for immediate replacement by the suppliers cost and risk.
- In the event of non-supply of item within the stipulated period ,liquidated damage @ 0.5% per week of the value of the balance amount involved in the delay subjected to maximum of 2.5% shall be realised from the bill of the supplier .An amount at par with 5% of the gross value of the bill shall be deducted from the bill towards security deposit after one month from the date of installation of instrument.
