





**TENDER PAPER FOR ENGAGEMENT OF TRANSPORTING AGENT UNDER S.N.P.  
IN KHORDHA DISTRICT FOR THE REST PERIOD OF 2018-19 & 2019-20.**

Sealed Tenders in the prescribed form are invited from the intending registered Transport Contractors/Agents having Valid Agents License under the Carriage by Road Act-2007 and the Carriage by Road Rule -2011 from concern Transport Authority for engagement of transportation of rice & wheat under S.N.P. from OSCSC Ltd/ FCI. point to all AWCs/ SHGs point in Khordha District for the rest period of 2018-19 & 2019-20 as per the prescribed terms and conditions. The approximate quantity of food stuff to be handled in a year and approximate value of the foodstuff in the Govt. rates(subsidies rate) are as follows.

Approximate quantity of foodstuff in Qntls. (Whole District) : Q. 48,000.00

The Sealed Tender shall be received by the D.S.W.O, Khordha on behalf of the Collector, Khordha by Registered Post/ Speed post/ by person till 5.00 P.M. on dt. 11.12.18 and will be opened on dt. 11.12.18 at 3 PM, in the Conference Hall of Collectorate, Khordha in the presence of the Members of the Tender Committee and the tenderer or their authorized representative by producing the letter of authorization. The tender received beyond the date & time shall be liable for rejection.

The tender will be in two parts i.e. Technical Bid (Part-I) & Financial Bid (Part-II). The bidders should submit their technical and financial bid separately in two envelopes and should be put into another cover super scribed as

The detailed tender paper along with the prescribed tender scheduled can be downloaded from the district website. The tenderer submit the tender paper along with D.D. of Rs. 3,000/- (Rupees three thousand ) only in favour of DSWO, Khordha (which is non-refundable) towards the cost of Tender Paper. The Tender Paper without D.D. of Rs. 3,000/- will be rejected.

**TERMS AND CONDITIONS OF THE TENDER**

- 1). The Tenderer shall carefully go through all the terms and conditions of the tender documents and submit the tender papers correctly and in complete form. The tender paper should be filled up properly and legibly without any correction/overwriting. No opportunity shall be given to the tenderers to rectify or amend any defect detected at the time of scrutiny. The rates should be written both in words and figures in the tender paper. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances and it should be valid for the rest period of 2018-19 & 2019-20.
2. "No individual, company, firm, corporation shall participate in the tender process unless it obtains or possess valid agent's license under the Carriage by Road Act-2007 and the Carriage by Road Rule -2011 from concern Transport Authority.

3. The successful tenderer shall be required to lift Wheat and Rice from F.C.I Depot/OSCSC Ltd. respectively and transport the same to all AWCs/Mini AWCs & all WSHGs of Khordha district (who supply chhatua) as per the order of the Collector/DSWO, Khordha within the specified period. After lifting of the rice & wheat from OSCSC Ltd./ F.C.I Depot respectively, the rice & wheat will be delivered at the AWCs/SHG points on the same day as per diversion order of DSWO / CDPO concerned.
4. It is the responsibility of the transporting agent to lift the rice/ wheat from OSCSC Ltd./ FCI Depot on proper weightment & FQ standard and deliver the same to the AWWs / AWHs / SHGs of Khordha district on proper weightment. In no circumstances short supply or delivery shall be made by the agent to the AWWs / AWHs / SHGs. The weighing machine shall be taken by the transporting agent along with the vehicle. The agent will be held responsible for the shortage and damage noticed if any during transit and delivery. The quality and quantity of the foodstuff being transported may be inspected by the Govt. officials authorized by Collector during transit and also at the delivery points. There shall not be any change both in quality and quantity of the food grains during transportation by the transporting agent and for any shortcomings in this front. The transporting agent shall be responsible and this shall be treated as misappropriation by the transporting agent. If any misappropriation is noticed during inspection or otherwise, a penalty shall be levied which would be equivalent to 10 times of the cost of misappropriated food grains apart from initiating criminal cases.
5. The tenderer should submit the following documents along with the tender paper. In absence of any document/paper in the tender form will be liable for rejection by the competent authority. The tenderer shall have to produce the original documents if necessary before the Tender Committee for verification.
  - i. Original tender paper duly signed by the tenderer as token of acceptance of the terms & condition of the tender.
  - ii. Original D.D. of Rs. 3,000/- (Rupees three thousand ) only in favour of DSWO, Khurda towards cost of tender paper.
  - iii. Attested copy of the Valid Agent License owned by the tenderer under the Carriage by Road Act-2007 and the Carriage by Road Rule -2011 from concern Transport Authority .
  - iv. Attested copy of valid Income Tax Pan Card.
  - v. Recent Solvency Certificate for Rs.25,00,000/- (Twenty five lakh) only for the whole district from the competent authority should be furnished along with the tender paper failing which the tender will be liable for rejection.

- vi. Certificate from any Govt. Organization about past experience and performance of the Tenderer in transportation of rice or any food materials. The accepting authority shall have the right not to accept tender(s) contractors who have not performed satisfactorily in preceding years under above programme.
  - vii. Earnest Money of Rs. 5,00,000/- (Rupees five Lakh) only for transportation for whole district in shape of KVP/NSC/F.D./Demand Draft duly pledged in favour of District Social Welfare Officer, Khurda shall be furnished along with the tenders. Tenders without Earnest Money will be liable for rejection. Cash/Cheque shall not be accepted. No request for transfer of any previous deposit or adjustment of earnest money for any claim payable will be entertained. Any deviation to the above stipulation will entail complete rejections of the tender paper. No tenderer shall be allowed to withdraw his tender/ Earnest Money Deposit until the tender is finalized. In case the successful tenderer refuse to be the Transporting Agent after acceptance of his tender the Earnest Money Deposited by him will be liable for forfeiture. The E.M.D of the unsuccessful tenderer shall be refunded after finalization of the tender; whereas the E.M.D of the successful tenderer will be kept as Security Deposit and will be released after successful completion of contract period , settlement of payment thereof and audit of such account and after obtaining the audit report. The Collector/DSWO is not liable for payment of any interest on the Security Deposit or any depreciation thereof. The breach of any terms and conditions as per agreement and failure/unwillingness to undertake transportation work by the selected tenderers within the time limit after acceptance of his tender may lead to forfeiture of E.M.D. The selected transporting agent will be black listed for any other Government tender, if he fails to perform the duties as per agreement in timely, regular supply of food grains on proper Weighment.
  - viii. The tenderer should have minimum two trucks / two mini trucks of his own for transportation for whole district List of trucks/ Mini Truck owned by the tenderer with up to date documents (Xerox Copy R.C. Book, Valid Insurance & Fitness Certificate duly attested) shall be furnished along with the tender Paper.
  - ix. The tenderer should file an affidavit either from the Executive Magistrate or from the Notary in support of that; he/she has no criminal background.
  - x. The tenderer should enclose the self attested copy of his Voter Identity Card / authorized agents of the tenderer.
6. The successful tenderer will be required to furnish a minimum Bank guarantee for Rs.10,00,000/- (Rupees ten lakh) for whole district the period of contract from the date of signing the agreement or for such amount as would be required by Collector, Khordha.

7. The successful tenderer shall have to enter into registered agreement with Collector, Khordha/ DSWO ,Khordha as per the terms and conditions mentioned in the specified agreement formant within 7 days of intimation of acceptance of his tender.
8. Payment shall be made against submission of bills on completion of the delivery of the stocks as per the orders of competent authority on production of printed serially numbered delivery challans duly acknowledged by the recipient of the stock to whom it concerned and as per the approved rate in corporate in the agreement. The District Social Welfare Officer, Khordha shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. The payment will be made subject to availability of funds under Transportation charges head under SNP and no advance payment will be made.
9. Good conducts, dealing with officials shall be an implied condition for continuance as Transporting Agent.
10. The Collector, Khordha may terminate the contract for violation of terms and conditions of agreement as well as any change of policy in the Government or for any reasons to be recorded in writing.
11. In case of violation of conditions of Tender the Agent will be booked under IPC, Essential Commodities Act. Prevention of Food Adulteration Act. and Prevention of Black Marketing Act.
12. The right of acceptance of tender rests with Collector, Khordha who does not bind himself to accept the lowest tender and also reserves the rights to cancel or reject any or all the tenders without assigning any reason thereof . In case of any dispute the orders/decision of the Collector, Khordha will be final & binding.
13. Tenderer should have GST Registration Certificate .
14. The financial bid of the tenderer will be opened after successful in the technical bid.
