3. The organization should have minimum 3 years experience in implementing animal feeding / animal welfare activities within jurisdiction of Bhubaneswar Municipality Corporation area.
4. The organization should have GST/PAN CARD.
5. The profile of the organization including total financial outlay and 3rd party evaluation.
6. Address proof of Office – Electricity bill / Telephone bill and resident of Bhubaneswar Municipality area.
7. 3 years audit statement of expenditures.
8. Work order/ agreement done during last 3 years and experience certificate in implementing in Govt. projects.
9. Firm/Agency/NGO should have valid food license and have Office under Bhubaneswar Municipality Corporation area
10. No. of experienced professionals working in that organization.

N.B:- Attach self attested Xerox copy of all above documents during participation in quotation process and bring original for verification at the time of opening of quotation .

2. The Bank draft will be returned to the disqualified bidder on the same date after completion of quotation.

3. The quotation document along with Bank draft must be submitted so as to reach the Office at the CDVO, Khordha on before **19.06.2021** by 5 PM in **Speed post / Courier**.
4. The quotation document without Bank draft after the due date and time will not be considered.
5. While sending quotation, the envelop must be super scribed for supply of Dog food for ABC Programme and date of opening of quotation.


