**Terms & Conditions**

- The intending tenderers are hereby informed that the above vehicle is to be auctioned without RC Book and no claim or complain shall be entertained for RC Book after auction the vehicle.
- The intending tenderers are advised to inspect the above vehicle parked at place mentioned above between 11.00 AM to 4.00 PM from 20.09.2019 to 04.10.2019 on all working days before submitting the tender.
- The intending tenderers are required to pay a sum of Rs. 1000/- (Rupees one thousand) only for the above vehicle as earnest money deposit in shape of Bank Draft in Favour of District Agriculture Officer, Khurda payable at SBI, Main Branch, Khurda (0116) along with tender papers.
- The amount offered by the bidders should be written clearly in words and figures against the vehicle.
- The tender papers should be sent in sealed envelope and subscribed in capital letters "OFFER FOR AUCTION SALE FOR DISPOSAL OF UNSERVICEABLE VEHICLE".

- F) The tender should reach the undersigned by Registered post/Speed Post or by hand on or before 04.10.2019 up to 1.00 P.M at the latest and tenders received till then shall be opened by the tender committee on the same day at 3.00 P.M in the office chamber of District Agriculture Officer, Khurda in the presence of the tenderers or their authorized representatives. If this day is declared as a Government holiday then the tender will be received and opened on the next working day as per the schedule time.
- G) After the acceptance of the highest bid, the highest bidder shall have to deposit 25 % of the accepted highest bid amount immediately on the spot and the rest 75 % within 7 days from the date of receipt of ratification/confirmation of the price. In case, he fails to make deposit of the total amount as per the tender within the stipulated time the deposit including the earnest money shall be forfeited to government without making any correspondence to the person concerned and the vehicle will be put to fresh auction sale.
- H) The successful bidder shall take permission and remove the vehicle from office campus of District Agriculture Officer's, Khurda with 7 days of deposit of the bid amount. In case failure to remove the vehicle within aforesaid time span, ground rent @1% of the tendered amount shall be charged for each day or part of the day till removal of the vehicle from the aforesaid place. If the ground rent so charged, exceed the sale price deposit, then the tenderer shall cease to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.
- I) Any deviation in stating of facts and figures shall make the tender liable for rejection.
- J) The authority reserves the right to cancel the tenders without assigning any reason thereof.






