
**TERMS & CONDITIONS**

1. Complete organisation details with name, address, telephone/ Fax no & E Mail ID.
2. The quotation should be supported with
  - a) EMD worth Rs. 1,00,000 /- (One Lakh) in the shape of One year Fixed Deposit/Term Deposit/ Postal Account Deposit through any nationalized bank duly pledged in favour of the Executive Engineer, RWSS –cum-APD(WATSAN) Bhubaneswar .
  - b) Copy of the PAN Card and GST certificate must be attached with the quotation.
3. The work should be completed within 30 days from the date of issue of the work order.
4. The date of receipt of sealed quotations in the tender box at the office of Executive Engineer, RWSS cum APD(WATSAN), Bhubaneswar is 31.01.2020 upto 3.00 PM and the quotation will be opened on 04.02.2020 at 3.00 PM in the presence of the committee members & the bidders or their authorized representative in the conference hall of DRDA, Khordha.
5. An affidavit towards authentication of document must be attached with the quotation.
6. The rate quoted should be inclusive of all charges like labour, material, T&P including cost of conveyance, installation charges.

  - Enamel painting of the IEC messages over the base should be done as per direction of the Authority.


- Painting materials must be used only of the following companies:
