The intending bidder are to submit the copies of valid GST Registration certificate, PAN Card and EMD of Rs.20,000/-(Twenty Thousand)only in shape of BD/DD/MR from any Nationalized Bank in favour of Executive Officer Jatni Municipality along with their bid failing which their bid shall not be taken in to consideration. After getting the work order If the bidder unable to provide the machine in stipulated time period the EMD amount shall be forfeited without any reason thereof. The EMD of unsuccessful bidder who are not awarded will be refunded after finalization of quotation.


Terms and Conditions:-

4. The bidders will bear all the responsibility for accident & Insurance coverage of the operator as well as the public if any at the time of execution of sweeping.
5. The bidder will pay the wages of operator & helper and the same will be reimbursed along with hire charges at the time of payment.
6. The payment will be made after certification of J.E & M.E.
7. The Agency should deploy the Driver & Operator for the machine and borne the cost of repair and maintenance of the machine.
