The quotation received incomplete and after scheduled date and time shall be rejected .Rates should be quoted for each items including GST and other taxes and the items are to be delivered at O/o CDVO, Khordha The undersigned reserves right to reject any or all quotations without assigning any reason thereof .All legal disputes if any relating to the quotation are subject to jurisdiction of court of law of Khordha district.

PREQUALIFICATION FOR QUOTATION:

1. The participating bidder should be an authorised Dealer/Distributor/Supplier having valid drug licence & GST registration.
2. The participating bidder who has been blacklisted by the State Govt./Central govt./any PSU is not eligible to participate in this procurement process through quotation.

TERMS AND CONDITIONS OF QUOTATION:

1. The quotation should be neatly typewritten without any correction/overwriting & each page of quotation paper should be numbered.
2. Supply should be made at the O/o-C.DV.O., Khordha within 07 days after receiving supply order.
3. The bidder should have a valid drug licence & GST registration.
4. The bidder should enclose self-attested copy of PAN, copy of valid drug licence, GST Registration certificate and GST clearance for last quarter.
5. The bidder can submit their quotation for individual or multiple items intend to supply from the list of medicines mentioned below inclusive of all taxes
6. The tax will be charged as per Govt. guideline.
7. The Payment shall be made after delivery of items in proper condition and as per specification through RTGS after submission of bills/vouchers. The bank details of the bidders should be mentioned on the body of bill.




