Sealed Tenders are invited from the interested reputed Travel Agencies / Tour Operators or private individuals who have valid GST Registration & PAN for providing vehicles of required specifications for "**MOBILE VETERINARY UNIT**" to be engaged in 10 blocks of Khordha district i.e. Chilika, Banpur, Tangi, Khordha, Begunia, Bolagad, Old town (BBSR), Jatni, Baliana and Balipatana which shall conform to the terms and conditions (Annexure-I) for MVU use in ARD Department, Khordha on monthly rent basis. The sealed Tenders should reach to the undersigned on or before **dt.18.01.2023** by 5.00 PM. The tenders will be opened on **dt.20.01.2023 at 11:00 A.M.** (Opening date may be shifted to any other date due to unavoidable circumstances) in presence of the Bidder or their authorized representatives. Absence of bidder/ authorized representative on the scheduled date & time, will not stop the opening of bid & bid related process. The undersigned reserves all rights to reject or cancel any or all Tenders without mentioning any reason thereof.

1. The vehicle to be hired is **TUV300 / Bolero / Sumo Gold / Ertiga** (the suitable one for MVU work, is to be preferred so that it should accommodate minimum three persons excluding driver with all need based equipment, medicines, chemicals & biological etc). In view of the high pollution through use of Diesel vehicles, it is preferable to hire **BS-IV** Compliant petrol vehicle.
2. The vehicle must be in Road Worthy condition, shall not be **more than three year old from the date of initial registration** and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage, proof of up to date Tax payment etc. which are mandatory for plying of vehicle.

3. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
4. The Driver should be well behaved, gentle and obedient in nature. He should be non-alcoholic
5. A sum of **Rs.1000/- (Rupees One thousand only)** shall be deposited by the intending bidders in shape of **Bank Draft** drawn in favour of the **Chief District Veterinary Officer, Khordha** along with the tender as bid processing fee, otherwise the application will be rejected. **No Account payee cheque will be accepted.** The bid processing fee Non-refundable.
6. The monthly rate of hiring charges is to be quoted separately in Financial bid **Annexure-III** (Excluding fuel). The maximum allowed hiring charges should be equal to or less than **Rs.31000/-** per month including GST. The bid containing hiring charges over and above **Rs.31,000/-** per month will be disqualified / cancelled.
7. The minimum average mileage of vehicle is 10 Kms. per liter of fuel.
8. The details of the make and year of manufacture of the vehicle, Registration No., Mileage (Kms. covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in **Technical bid** information to be furnished with the Tender (Annexure-II).
9. The application form of tender containing eligibility criteria, scope of the work, terms and conditions of the tender, General Bid Information etc. will be available at the CDVO office Khordha on payment of Rs.100/- (Rupees one hundred) only Nonrefundable+ GST @ 12% (Total Rs.112.00) from **dt.29.12.2022 to dt.18.01.2023 up to 3.00 P.M.** or can be downloaded from Odisha Govt. website **www.khordha.nic.in** from dt **29.12.2022**. INSTRUCTION TO BIDDERS

A. General Information

The Chief District Veterinary Officer, Khordha requires the services of reputed Travel Agencies/ Tour Operators or private individuals who have valid GST Registration for providing vehicles of required specifications for “**MOBILE VETERINARY UNIT**” to be engaged in 10 blocks of Khordha district i.e. Chilika, Banpur, Tangi, Khordha, Begunia, Bolagad, Old town (BBSR), Jatani, Baliana, and Balipatana which shall conform to the terms and conditions (Annexure-I) for MVU use in ARD Department, Khordha on monthly rent basis.

The period of contract for providing the aforesaid service will be ideally **1 (one) year** from the date of effectiveness of the contract. The contract may be extended for another one year on mutual consent depending upon the performance of the Service Provider and at the discretion of the authority. The authority reserves the right to terminate the contract at any time after giving 30 days' notice to the Service Provider.

B. Submission of Bid:

The complete proposal in all respects as specified must be accompanied with a Non-refundable amount of **Rs.1,000/- (Rupees one Thousand only)** towards **Bid Processing Fee** in shape of **Demand Draft** in favour of “**Chief District Veterinary Officer, Khordha**”, drawn in any scheduled commercial bank and payable at Khordha failing which the bid will be **out rightly rejected**. The bid should be sent through Speed Post / Registered Post / Courier / drop in Tender box at CDVO office, Khordha so as to reach the authority by due date & time.

SCOPE OF THE WORK

A. SERVICES OF MVU

The Chief District Veterinary Officer, Khordha Invites sealed bids from the eligible bidders for providing the services of MVU at locations as per **Annexure-I (in Khordha district only)**

1. MVU Vehicle will be engaged in conducting MVU camps at village level by MVU VAS / AVAS/ BVO/ DD, DVH of concerned block. Minimum Twenty camps in twenty will be organized in a month. The camps at village level will be started from 7:00AM. Accordingly the man power for MVU should be available.
2. In case of emergencies like Natural Calamity and Disease outbreaks, MVU vehicles are to be utilized along with MVU staff to render required services as and when desired by the competent authority. MVU vehicles along with MVU staff will also be utilized for providing emergency health care services to stray and destitute animals as in case of road accidents by getting calls from state level Animal Help Line.
3. Though MVU camps will be organized for 20 days in a month, the vehicle will be engaged throughout the month as per the direction of authority and log book will be maintained accordingly mentioning the speedometer reading.
4. The Service Provider shall ensure that the personnel deputed are as per the scope of the work, physically and mentally healthy and not more than 60 years of age or less than 21 years of age and willing to work as per need of authority.
5. The full particulars of the personnel to be deployed by the service provider including their names and addresses shall be furnished along with testimonials before they are actually deployed for the job.
6. The Service provider / Vehicle owner shall visit the Mobile Veterinary Unit of the concerned block in every fortnight and review the service performance of its personnel. During the fortnight visit, Service provider / Vehicle owner will also meet the representative of the Authority dealing with service under the contract for mutual feedback regarding the work performed and removal of deficiencies, if any, observed in their working.
7. The day to day functioning of the services shall be carried out in consultation with and under direction of the Authority.

B. JOB DESCRIPTION & QUALIFICATION OF MVU ATTENDANT:

- Along with driver, the Mobile Veterinary Unit Assistant (MVU Assistant) will be provided by the vehicle owner whose vehicle will be engaged in MVU. Honorarium to MVU Assistant, as per agreement i.e.Rs. 13000/- per month.
- The engagement of MVU Assistants by the vehicle owners will be purely temporary and will be terminated at any time without any notice. Engagement of MVU vehicle will be done each year and accordingly the vehicle owner will provide MVU Assistant every year. The vehicle owner shall provide the MVU Assistant in consultation with the concerned BVO and CDVO as per the below mentioned points.
- A candidate falling in the below mentioned categories and below 60 years of age, will be given preference in the following order to work as Mobile Veterinary Unit Assistant.
 - Candidates having qualification of Diploma in Animal Science
 - Candidates having qualification of +2 Vocational in Animal Husbandry allied subjects like dairy Science, poultry science etc.
 - Candidates working as GOMITRA
 - Candidates working as Pranimitra
 - Candidates having qualification of +2 Science
 - Candidates having qualification of +2 in any stream
 - Para Vets trained in LITCs (Below 65 years of age)

Annexure- I

GENERAL TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the bidder for providing a vehicle on hire on monthly rent basis.

1. Vehicles for “**MOBILE VETERINARY UNIT**” to be engaged in 10 blocks of Khordha district i.e. Chilika, Banpur, Tangi, Khordha, Begunia, Bolagad, Old town (BBSR), Jatni, Baliana and Balipatana which shall conform to the terms and conditions on monthly rent basis.
2. The vehicle to be hired is **TUV300 / Bolero / Sumo Gold / Ertiga** .In view of the high pollution through use of Diesel vehicles, it is preferable to hire **BS-IV** Compliant petrol vehicle.
3. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as valid Registration certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and Driving License of the driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life/ injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The vehicle owner shall be responsible for all such litigation.
4. The hire charges to be paid for monthly basis is final but does not include cost of fuel i.e. Petrol / Diesel, which is to be paid separately basing on actual consumption. All the expenditure of the vehicle towards major or minor repair, replacement of spare parts. Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder. The hiring charges of vehicles will be inclusive of lubricants, spare parts, maintenance, and **salary of the driver**, payment of insurance/ Road tax etc. required for operation of vehicle.
5. It shall be the responsibility of the bidder to provide a good driver who should be non-alcoholic, well behaved, gentle and obedient in nature and the salary of the driver shall be borne by the owner.
6. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle and should be available as and when required.
7. In case, absence of driver / MVU Assistants for whatsoever reasons the owner shall arrange substitute alternate driver / MVU Assistants for the vehicle.
8. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
9. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
10. Monthly hire charges and reimbursements towards cost of fuel (as per actual consumption) of selected bidder will be paid in every succeeding month, as far

- as possible within fifteen days of the submission of bills by the bidder and no advance payment will be made.
11. The vehicle shall not be more than 03(Three) years old from the initial registration and also in good running condition during the period of contract.
 12. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
 13. In case the provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to give two (02) months' notice before such withdrawal of service and termination of agreement.
 14. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit and pending hiring charges of the vehicle.
 15. The vehicle should be kept clean and tidy and **stickering of vehicle will be done as specified by ARD department from time to time**. Stickering on the vehicle will be done by this office. The driver will see that, stickering is not mutilated. The vehicle must be branded / stickered front, back and side displaying different flagship programme of the department.
 16. No extra charges will be paid for emergency night halts at out station and the lodging / boarding charges of the driver will be borne by the owner of the vehicle.
 17. One can't submit more than one bid for same block. One Registered vehicle can't be use for bidding in more than one block. In case of any deviation the bid will be cancelled
 18. **The owner has to supply Petrol / Diesel for the month which will be reimbursed along with hiring charges** on production of fuel bills countersigned by MVU, VAS /BVO/DD DVH.
 19. An agreement will be made with the Service provider / vehicle owner before engagement of his vehicle on M.V.U work.
 20. A sum of Rs.1000/- shall be deposited by the intending bidders in shape of **Bank Draft** drawn in favour of the **Chief District Veterinary Officer, Khordha** and submitted along with the tender as bid processing fee (non-refundable). **No Account payee cheque will be accepted** otherwise the application will be rejected.
 21. Bid security declaration (as per enclosed format) is mandatory.
 22. **The successful bidder will have to submit the bankers guarantee form (Model format attached) @ 3% of the total contract value at the time of executing MoU.**
 23. The monthly rate of hiring charges be quoted separately in the general bid information (excluding fuel).
 24. The Hiring charges do not include fuel cost (petrol/ diesel) which is to be paid separately basing on actual consumption.
 25. Vehicle should be regularly serviced and kept under optimum running condition so as to avoid any break down and accidents attributable to lack of maintenance and upkeep. In case of break down an alternate vehicle should be immediately arranged by the service provider / owner without compromising the services of Mobile Veterinary Unit.
 26. GST registration is compulsory for Service provider / Vehicle Owner to provide hired vehicles to Government offices.

27. Service provider or individual (Vehicle Owner) must provide copy of PAN & GST registration number.
28. GPS Tracing Device (Vehicle Tracking Unit) will be installed in each hired vehicle meant for MVU and it will be the responsibility of the vehicle owner for good upkeep of the device. The vehicle owner will be held responsible for any damage of device and monetary recovery will be made from the vehicle owner for the loss incurred. In case of breakdown of vehicle is expected for more than 10 days, the owner will bear the cost of installation of the GPS Tracing device in the alternate vehicle.
29. Along with driver, the Mobile Veterinary Unit Assistant (MVU Assistant) will be provided by the vehicle owner whose vehicle is engaged in MVU. Honorarium to MVU Assistant will be as per agreement i.e.Rs. 13000/- per month.
30. The engagement of MVU Assistants by the vehicle owners will be purely temporary and can be terminated at any time without any notice. Engagement of MVU vehicle will be done each year and accordingly the vehicle owner will provide MVU Assistant every year. The vehicle owner shall provide the MVU Assistant in consultation with the concerned BVO and CDVO as per the below mentioned points.
31. A candidate falling in the below mentioned categories and below 60 years of age, will be given preference in the following order to work as Mobile Veterinary Unit Assistant.

32. Agreement will be made with the service provider/ vehicle owner for engagement of the MVU vehicle and MVU Assistant on yearly basis.
33. In case of natural calamity like flood, cyclone, drought, lightening, Heat waves etc. out breaks of disease, post mortem of insured livestock, emergency healthcare services for stray and destitute animals and other livestock emergency service, MVU may be engaged to serve the livestock and to cater the need based service to the farmers. Additional fuel cost for such activities shall be borne by the CDVO Khordha.
34. The hired vehicles cannot be used for any private / commercial purpose during the period of engagement, even beyond the office hours. After completion of work in a day, the vehicle should be kept at the disposal of the BVO/ DD, DVH, preferably in the campus of the VD/VH situated at block head quarter.
35. The I/c MVU VAS/ AVAS and BVO / DD, DVH will be responsible for any deviation of operational guidelines of MVU scheme.
36. All pages of documents are to be serially numbered and bear signature of the bidder/his authorized person.

EVALUATION PROCESS:

1. In view of the high pollution through use of Diesel vehicles, preference will be given to hire **BS-IV** Compliant petrol vehicle within the maximum allowed hiring charges equal to or less than Rs.31000/- per month including GST. In case of non-availability of **BS-IV** Compliant petrol vehicle, Diesel vehicles will be considered.
2. First the technical bids for the respective blocks will be opened and valid bidders will be shortlisted (block wise) as per the requirements mentioned in checklist.
3. Then the financial bids of the qualified bidder in the technical bid will be opened (block-wise) and the selection of the successful bidder will be done on the basis of lowest rate quoted (L1) for monthly hiring charges.
4. In case of no bidder found qualified in technical bid for a particular block, then an exhaustive list of all the bidders, except L1 bidders of other blocks (Block selected with vehicle) will be prepared basing on the ascending order of the monthly hiring charges quoted.
5. From this list the lowest price quoted bidder will be given an option to engage his/her vehicle in the **block with no bidder** and the negotiated hiring charges will be same as price quoted by bidder or less than that of succeeding lower bidders . if the bidder did not agree with the negotiated hiring charges, then the option will be extended to the succeeding lower bidders in the list till one vehicle is engaged for that block.
6. If more than one block are found with no valid bidders, the lowest rate holder of the exhaustive list thus prepared will be given option to engage his/her vehicle in any of the blocks with no bidder and this process will continue with the succeeding lower bidders in the list till all the blocks are assigned with one vehicle.
