The Proposal should reach in the office of the Executive Officer, Jatni Municipality on or before 01.03.2024 by 11.00 am through courier/speed post/registered post or by hand and the same will be opened on the same day at 4:00 pm in the presence of Transgender Groups / WSHG /ALF/ Ragpicker Groups and their authorized agent if any present. The bidder should submit the Resolution copy of Expression of Interest, experience certificate, Rs.3000/- as EMD in shape of bank draft/bankers cheque drawn in favour of the Executive Officer, Jatni Municipality from any nationalized bank and attach the same along with the proposal documents. This Office shall not be held responsible for any postal delay in receipt of the proposal. Selection will be given to WSHG /ALF/ Ragpicker Groups having experience in SWM activity. To assess the capacity of Transgender Groups / WSHG /ALF/ Ragpicker Groups Processing of Legacy waste with sufficient manpower shall be submitted along with attached documents. The undersigned reserves the right to reject any or all the proposals without assigning any reason thereof.


Terms & Conditions

1. The term of proposal is valid for One year from the date of execution of agreement.
2. The Transgender Groups / WSHG /ALF/ Ragpicker Groups shall provide required manpower for Processing of waste minimum 1-2 tons per day
3. The Transgender Groups / WSHG /ALF/ Ragpicker Groups shall provide the personal protective equipment to the workers at processing area.
4. The Transgender Groups / WSHG /ALF/ Ragpicker Groups will hold responsible for any loss, damage, theft of equipment's, loss of properties, machinery etc.
5. If the Processing work is not satisfactory then the Transgender Groups / WSHG /ALF/ Ragpicker Groups will be terminated from the work one-month prior notice and security amount will be forfeited to the account of Jatni Municipality.
6. The labour shall be provide minimum wages as per orders of the Labour Department from time to time.


