

TERMS AND CONDITION FOR STITCHING OF UNIFORMS

1. Sealed tender for the supply of the articles shown in the attached statement are invited by the undersigned on behalf of Navodaya Vidyalaya Samiti, up to **04.00 P.M** Date: **22.06.2024**. The tender should be sent under strong sealed cover marked as **“TENDER FOR STITCHING OF UNIFORMS”** and not by the name. The tender will be opened in the office of the Principal **on 24.06.2024 at 10.00 A.M.**
2. The tender should be submitted according to the terms and conditions specified in paragraphs 3 to 12, unless specified in otherwise in the Tender, it shall be construed that the terms and conditions stipulated hereunder have been agreed to.
3. The tenderer should submit his/her tender form along with Earnest money amounting **Rs.5000.00 (Rupees five thousand)** only in shape of online deposit to SB Account No.**30950185532** or in the form of Bank Draft In favour of the **Principal, Jawahar Navodaya Vidyalaya, Khurda payable at Khurda, Bazar Branch, IFSC Code: SBIN0012027** which will be refunded in the event of rejection of the tender.
4. The rate quoted by the Tailor shall hold good up to **30.04.2025**.
5. The measurement for stitching of Uniforms of the students will be taken in the presence of House Master/House Mistress/Class Teacher/Matron and signature of the teacher should be taken in the measurement list.
6. Measurement of the uniforms should be taken on free size so that, student can use for two years from the date of stitching.
7. The Tailor will complete the stitching work in the Vidyalaya campus within the stipulated time or will be decided by the Vidyalaya abiding the rules and regulations of the residential culture of the Vidyalaya. Tailor is not allowed to take the Cloth materials outside of the Vidyalaya premises under no circumstance
8. If the Tailor will fail to complete the works within the stipulated time the Chairman, P.A.C reserves the right to cancel the tender and the party will loose the EMD/Security Deposit and work will be completed by any other party/tailor.
9. The required cloth for Uniforms as approved by the P.A.C will be issued by the Vidyalaya. The stitching charge will be inclusive of all other items viz; Thread, Buttons, Chain locks, Hooks, Pocket cloths etc as required for the Uniforms.
10. The approved Tailor will deposit the Security Deposit as decided by the Vidyalaya within the stipulated time failing which the EMD thus deposited with the Vidyalaya will be forfeited and the tender will be rejected.
11. The Amount of Security Deposit shall be retained by the Samiti/Vidyalaya for a period of six months from the date of completion of supplies as a safeguard against any defect appearing in the stitching within the period. In the event of defective stitching Tailor will attend such defect at his own cost.
12. Terms and conditions of tender paper must be submitted with the sealed tender duly signed by the proprietor with seal in every page.
13. Copy of Money receipt of JNV, Khurda must be attached with the tender bid.
