

It is brought to your notice that the following discrepancies were found during scrutiny of the Candidate's Election Expenditure on 18.05.2024:

1. The candidate has to update the registers upto 17.05.2024, but it is submitted only upto 16.05.2024.
2. The proof of admitting the expenses in the registers of MLA of the same party who participated in rally/meeting/road show along with the MP candidate is not submitted stating the reason that the accounts register of MLA candidate was not fully ready and sought some time to update and will be reconciled with the Shadow Observation Register.
3. Certain differences in relation to German Hanger (tent) rent paid are found less than the rate chart. The same needs to be included in the accounts of the Candidate Register.
4. The candidate has not included hiring charges of helicopter in the register which is finding place in Shadow Observation Register.
5. Till date, the candidate has conducted several rallies jointly with MLA Candidates in the ACs of PC and also independently. However, no expenditure related to flags, caps, uttariya & gamuchha and paper flags etc are booked in candidate register stating the same as party expenditure. Since the candidate has participated in those events personally, the expenses related to items stated above and expenses related to that arrangements shall be included in the accounts of candidate fully or proportionately as the case may be.

In pursuance of the Commission's Order No.76 / Instructions / EEPS / 2015 / Vol-II, dated 29th May, 2015, you are to be issued a notice informing that you have to produce the day to day accounts in proper manner as required under Section 77(I) of the Representation of People Act,1951 .

We are in receipt of the aforesaid Notice for Discrepancy found during inspection of our Election book of accounts on dt 18.05.2024 and a parawise reply to the aforesaid notice is submitted as under for your kind perusal, consideration and record.

1.Sir The said discrepancy arose because of non-recording of certain expenditure jointly organized with the MLA Candidate on Dt 17.05.2024. Since the bills were received subsequently on Dt 18.05.24 in our office and since we were in your Honour's Khurda office to present the said expenditure register the same could not be updated/recorded on the date of inspection. However, the same is already recorded now and produced for your verification/inspection.

2. As regards non submission of proof of expenses/vouchers for the rally/event organized by the MLA Candidate wherein the MP candidate has also participated we shall humbly submit that the event is mostly organized by the MLA Candidate and we record all the expenses in our expense register. Some vouchers which are supposed to be supplied/handed over by the MLA candidate were not received by us but were submitted to their respective RO at the time of inspection of their expenditure register. The same may verified for the authenticity of our contention. However, we undertake to be more persuasive in future in obtaining the expenses vouchers from the MLA Candidate in future.

3.Sir as regards the expense on German Hanger we have shown as per invoice received from event organizer. The rate chart mention about

the individual items and also about the complete package of german hanger which also includes chairs, lights. Carpet podium etc. The difference is arising only because individual items are calculated separately/individually and not as a complete package of german hanger which includes items mentioned above.

4. Sir the hiring charges has since been booked in the expenditure register.

5. Sir We would like to submit that expenses relating to Uttariya, Flags and paper flag etc. containing party symbol has not been booked in the expenditure register. We would like to submit your kind self that those flags were provided by the Biju Janata Dal and they were embossed with party symbol only. There was no mention of candidate's name or photographs, therein. Accordingly, the same has not been booked. A copy of the party certificate is submitted to you for your kind perusal. Besides relevant extract of instruction from Candidate's Hand Book is also submitted for your kind perusal.





period. All expenses relating to the rally or procession organized while filing nomination are included in the accounts of the candidates.

7) **MEMBER OF PUBLIC AND EXPENDITURE THEREOF:** When members of public attend a public rally/procession/public meeting of candidate(s) by using their own personal vehicle, without receiving any payment or reimbursement from anybody, it shall not be included in the expenditure of the candidate. However, the personal vehicles used in the rally or public meeting for campaign purpose by putting flags or banners or poster for the benefit of any candidate(s) shall be included in the expenses of the candidate(s). If the commercial vehicles bearing commercial registration number are used for rally or public meeting of any candidate(s) the expenditure on such vehicles shall be included in the account of the candidate(s).

8) **PERSONAL VEHICLE OF CANDIDATE AND EXPENDITURE THEREOF:** One personal vehicle owned and used by the candidate(s) for campaign purpose shall be treated as campaign vehicle and notional expenditure on fuel and driver salary as per the market rate shall be included in the accounts of the candidate(s). In case other vehicles, owned by the candidate(s), are used for campaign purpose, then the notional expenses as per the notified rate for hiring of such vehicles shall be calculated by the candidate(s).

9) **EXPENDITURE ON VEHICLE OF THE DISTRICT LEVEL PARTY OFFICER BEARERS:** The expense on the vehicle of the district level party office bearers/leaders (other than star campaigners) for the purpose of their visit to multiple ACs within the district for electioneering shall not be included in the accounts of candidate(s). If the district functionary himself is a candidate, contesting from the same district and such vehicle is used for his movement in the constituency from where he is contesting, or such vehicle is used for campaign for any candidate(s), then the hiring charges of the vehicle shall be included in the accounts of the candidate(s) using the vehicle for campaign purpose.

10) **EXPENSES ON FLAGS, MUFFLERS OR CAPS:** The expense on such items of flags, mufflers or caps with party symbol shall be accounted for by the party concerned as its election expense. If they bear the name(s) or photo(s) of candidate(s), it shall be added to the accounts of the candidate. However, supply and distribution of main apparels like saree, shirt, T-shirt, dhoti etc. by party/candidate is not permitted as it is bribery of voters.

11) **EXPENDITURE ON BARRICADES AND ROSTRUMS ETC.**


