The intending bidders are advised to inspect the reject/damaged Tubewell spare parts now available inside the campus of Office Of The Block Development Officer, Khordha on any working day during Office hours between 10.00AM to 3.00 PM before submitting the tender/bid. Each bidder to quote price of auction material taking weight as a unit i.e. they should quote their price against Rs.17.00/kg.. Each tender / bid should accompany an earnest money deposit of Rs. 33,600/- (Rupees Thirty Three thousand Six Hundred) only in shape of DD/Bank Draft in favour of BDO, Khordha payable at SBI Main Branch, Khordha which will be returned to bidders with valid proof of identity whose tenders/bids are not accepted except in the case of successful bidder.

2. The tender / bid should reach the undersigned in the **Drop Box only** on or before 30.07.2024 till 3.00PM at the latest and the tenders / bids received shall be opened by the undersigned at 3.00PM onwards on the same day in the Office Chamber in presence of the bidders or their authorized agents. If this day is declared later as Govt. Holiday then the tenders / bids will be received and opened on the next working day as per the scheduled time.

3. The highest bidder whose tender / bid is accepted shall deposit 25% of the quoted amount within 2 days as initial deposit. The bidder shall deposit the balance 75% amount (of the total quoted amount) within seven days. In case the bidder fails to make deposit of the total amount as per tender / bid within the stipulated time, the deposit including the earnest money shall be forfeited.

4. The successful bidder shall take permission and remove the reject / damaged Tube Well Spare parts from BDO, Khordha premises within two days of deposit of the total amount. On failure to remove the reject / damaged Tubewell spare parts within the aforesaid time. Ground rent @ 1% of the tender amount shall be charged per day or part of the day till removal of the reject / damaged Tubewell spare parts from the premises of BDO, Khordha. If the ground rent so charged exceeds the sale price deposited, then the tender / bidder shall cease to have any right on the reject / damaged Tubewell Spare Parts and the amount deposited by him shall be adjusted towards ground rent.

5. GST @18% shall be deposited by the highest bidder on the quoted amount additionally.
