1. The bidders can download the tender from the District Web Site: <https://khordha.odisha.gov.in> and submit the bid with Tender Paper Cost (Non-returnable) of Rs.3,000/- (Rupees Three Thousand Only) and EMD (Returnable) Cost. Rs.10,000/-(Rupees Ten Thousand) only in shape of Demand Draft in favor of "ZSS NON-NRHM KHORDHA" Payable at KHORDHA.
2. The tender paper will be rejected if the bidder changes any clause or Annexure of the bid documents downloaded from the website.
3. Sealed tenders must be received on or before 22.12.2025 till 11:00 A.M. Any tender document received after the due date and time will be rejected/returned to the sender unopened. The tender paper must be received through Speed Post/ Courier only. The Sealed tenders will be opened on 22.12.2025 at 12:30 P.M. in the presence of Purchase Committee Members. Bidders /their authorized representative may remain present at the time of opening of tender.
4. The CDM & PHO, KHORDHA shall have no responsibility for any delay / Omission on part of the bidder and reserves the right to reject any or all the tenders without assigning any reason thereof.
5. The bidder(s) are to submit their tenders in separate sealed covered envelopes for Technical Bid and Financial Bid by superscripting Cover 'A' (Technical Bid) and Cover 'B' (Financial Bid) & both the sealed covers should be put into a third outer cover which should be superscripted as "Tender for Supply of Food Catering Service under NHM, KHORDHA" and Tender Reference No 19151/DPMU/NHM/KHD/2025-26.
6. The sealed tenders will be opened by the CDM & PHO, KHORDHA in the Office Chamber, O/O- CDM&PHO, KHORDHA on dated 22.12.2025 at 12:30 PM. The bidder or their duly authorized representatives are allowed to be present during the opening of the tenders if they desire.
7. The rate quoted by the bidder should be inclusive of all taxes.
8. Bidders should submit the valid Food License.
9. The Authority will not make any advance payment to the organization. The organization will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in that regards.
10. Under no circumstances the successful bidder shall appoint any sub-contractor or sub-lease the contract. If it is found that the organization has violated these conditions the contract will be terminated forthwith without any notice and security deposited by the organization shall be forfeited.



11. Rates quoted against this tender notice shall remain valid up to 12 months after the award of contract. No request for an increase in rates, if any, will be allowed or entertained during this period. However, the contract may be renewed for another one year by mutual consent and satisfactory performance of the successful bidder.
12. Bidders should submit the photocopy of valid GST Registration Certificate & PAN Card.
13. In case of non receipt of required number of bids the bidding period may be extended by the tender inviting authority.
14. The bidder should have atleast one year experience in the food catering services.
15. The bidder has to submit affidavit in Non-Judicial Stamp Paper with appropriate value (i.e Rs.20/-) that his or her agency has not been blacklisted by any Govt./PSU organization.
16. Bidders should not change the item list as per the tender Sl. No.
17. Bidder has to submit Annual Turnover Certificate (**Annexure- I**) for FY 2023-24 duly certified by a Chartered Accountant mentioning UDIN.
18. The bidder must submit the Declaration form **Annexure - II** duly signed by the tenderer before the Notary public / Executive Magistrate.
19. In case of tie in quoted price, the bidder having maximum annual turnover will be considered as L1 bidder.
20. The successful bidder will supply the food items adhering to the specification as per the purchase order issued to carry out day to day work of O/o CDM&PHO, KHORDHA.
21. The agency has to submit the bill within 3 days of completion of the programme and payment will be made to the Bank account of the agency within 15 days after verification of supporting documents.
22. The agency has to take the responsibility to supply the food with Plates, Glass, and Container etc.
23. The suppliers shall also ensure that the quality and quantity have to be as per the supply order and approved rate contract.
24. Delivery of the materials shall be made by the supplier at their own cost & risk.
25. The price should be quoted inclusive of all taxes & catering charges on per plate basis and the agency will arrange the personnel to serve the food at the designated venue.
26. The agency cannot use non biodegradable polythin, polythin of less than 50 macro meter or thermocool materials as disposable serving materials.
27. The utensils used for preparation & services must be cleaned & hygienic to the satisfaction of the consumer.
28. For any dispute, decision of CDM&PHO-cum-District Mission Directorate, KHORDHA shall be final.
