TENDER NOTICE

PROCUREMENT OF OTHER COMPONENTS FOR AWCs UNDER SAKSHAM ANGANWADI

As per the file order of the Sub-Collector-cum-Chairman of the tender committee, the Office of the Child Development Project Officer (CDPO), Bhubaneswar (Urban)-I, invites sealed quotations from authorized firms/suppliers for supply of the following articles under "Other Components" of the Saksham Anganwadi Initiative (Phase-I) for Anganwadi Centres.

1. Availability of Tender Document

Interested bidders may obtain the detailed terms and conditions of the tender by downloading the tender document from the official website: www.khordha.odisha.gov.in

2. Submission of Tender

The tender shall be submitted in two separate parts, namely:

- Part-I: Technical Bid (Cover-A)
- Part-II: Price Bid (Cover-B)

Both the Technical Bid and Price Bid shall be submitted in separate sealed envelopes, clearly superscribed as "Technical Bid – Cover A" and "Price Bid – Cover B" respectively.

Both envelopes shall then be placed in a third outer envelope, superscribed as:

"Tender for Procurement of Other Components for AWCs under Saksham Anganwadi – CDPO, BBSR (Urban)-I" along with address and Contact Number

3. Last Date of Submission

The sealed tender should reach the office of ICDS Project, BBSR (Urban)-I on or before 24.03.2026 at 11.00 AM.

TERMS AND CONDITIONS

It may be noted that the discount rate shall be quoted in terms of percentage (%) against the Other Components. The discount rate shall be calculated on the Maximum Retail Price (MRP). Only those bidders who qualify technically (as per submission of valid documents in Technical Bid – Cover A – Part I and fulfilment of all terms and conditions of the tender document) shall have their Price Bid (Cover B – Part II) opened.

1. The discount rate shall be inclusive of all taxes, transportation charges, and other incidental expenses, and must be quoted in percentage (%) up to two decimal places. The percentage of discount shall be calculated on the MRP.
2. The quoted discount rate shall remain valid for a period of one year, which may be extended until the finalization of the next tender with the mutual consent of both parties.
3. The selected supplier shall be responsible for supplying the above-mentioned items as per the supply order on a door delivery basis for the Office of ICDS Project, BBSR (Urban)-I.
4. The supplier shall ensure that the quality and quantity of the supplied items strictly conform to the supply order and the approved rate contract under the tender.
5. The mirror shall be fixed firmly on the wall of the concerned Anganwadi Centre.
6. The firm must possess valid PAN and GST Registration Certificates, copies of which must be enclosed with the tender documents.
7. The supply of items shall be made within 07 (two) days from the date of issue of the supply order by the Office of ICDS Project, BBSR (Urban)-I. The supplier shall submit the bill for payment at the approved rate clearly mentioning MRP, applicable taxes, discount rate, and quantity of items supplied. The transportation and delivery of items shall be the sole responsibility of the supplier, and delivery must be made on a door delivery basis.
8. In case of failure on the part of the approved supplier to supply the items within the stipulated period as per the supply order, the ICDS Project, BBSR (Urban)-I shall be at liberty to procure the items from other sources. Any excess expenditure incurred in such procurement shall be recovered from the approved supplier, and the same shall be adjusted against the security deposit.
9. The firm must submit Income Tax Return filing acknowledgements for the Financial Years 2022-23, 2023-24, and 2024-25.

10. The firm must have an average annual turnover of at least Rs.10,00,000/- during the Financial Years 2022-23, 2023-24, and 2024-25.
11. The bidding agency shall submit an undertaking stating that the firm has not been blacklisted or debarred by the tender inviting authority or by any State Government or Government of India organization. This undertaking must be furnished on a Non-Judicial Stamp Paper worth Rs.20/- duly notarized.
12. The tender must be accompanied by an Earnest Money Deposit (EMD) of Rs.5000/- and Tender Fee of Rs.1,000/- (compulsory) in the form of Demand Draft drawn on any Nationalized Bank in favour of CDPO, BBSR (Urban)-I payable at Bhubaneswar/Khordha. Tenders not accompanied by EMD and Tender Fee shall not be considered. The EMD of unsuccessful bidders shall be returned without interest after finalization of the tender. The EMD of the successful bidder shall be retained as Security Deposit and refunded upon successful completion of the work without interest.
13. Under no circumstances shall the successful bidder appoint any sub-contractor or sub-lease the contract. If it is found that the successful bidder has violated this condition, the contract shall be terminated forthwith without prior notice, and the security deposit shall be forfeited.
14. If any item is damaged or lost during transit, the same shall be replaced by the supplier within a reasonable period as prescribed by this office to avoid delay.
15. If any item is found defective or not functioning properly within the guarantee/warranty period, the same shall be replaced by the supplier within a reasonable period as prescribed by this office.
16. The discount rate must be inclusive of all taxes, transportation, and other charges; otherwise, the offer shall be liable for rejection.
17. In case two bidders quote the same lowest percentage of discount, the bidder having the highest average annual turnover shall be awarded the contract.
18. The tender should reach in prescribed format to the "CDPO, BBSR (Urban)-I, Plot No-252, AT/Po.-BJB Nagar /Dist- Khordha, PIN-751014" through Speed Post/Regd. Post /Courier only by 24.03.2026 till 11.00 A.M. The tender shall be opened on i.e. 24.03.2026 at 3.00 PM in the Chamber of the Sub-Collector, Bhubaneswar in the presence of bidders or their authorized representative who may wish to be present. The envelope must be superscribed with "TENDER FOR OTHER COMPONENTS (SAKSHAM ANGANWADI CENTRE)" The tender should reach in the prescribed format to the following address:
19. All documents submitted must be duly signed by the authorized signatory of the organization.
20. If no suitable bidder is found, the Tender Committee reserves the right to relax the terms and conditions of the tender.
21. All legal disputes shall be subject to the jurisdiction of Bhubaneswar Courts only.
22. The Sub-Collector, Bhubaneswar and CDPO, BBSR (Urban)-I reserve the right to accept or reject any or all tenders or any part thereof without assigning any reason.
23. Payment will be made after successful supply, installation (wherever applicable) and verification of materials.
