

PROCEEDING OF THE PRE-BID TENDER CALL NOTICE COMMITTEE MEETING FOR SELECTION OF CFMS FOR SPL. CIRCUIT HOUSE BHUBANESWAR ON DTD.23.06.2026 AT 11:0 A.M.

The Tender Committee Meeting was held on **23.06.2026 at 11.00 A.M.** in the Conference Hall of the Collectorate, Khordha. The list of members present in the meeting is enclosed at **Annexure-I**.

At the outset, the **ADM, Revenue**, Member of the Committee, welcomed all the members and requested them to discuss the clarifications sought by different agencies regarding the tender.

A total of **03 (three) clarifications** were received from the bidders, as detailed below:

1. **SATYAM SECURITY AND ALLIED SERVICES** sought clarification on whether Security Guards shall be treated as "Unskilled" or "**Semi-Skilled**" for the purpose of minimum wage calculation and submission of the financial bid.
2. **PRATYUSH** sought clarification regarding the eligibility criteria mentioned in the Checklist of Eligibility (Page No. 40, Criteria Point No. C), specifically whether registration under the **Odisha Shops & Establishments Act 1954** would be accepted in place of registration under the **Delhi Shops & Establishment Act, 1954**.
3. **PEOPLES FORUM** sought clarification regarding eligibility for participation in the tender process.

After detailed deliberation, the Pre-Bid Tender Committee unanimously resolved the following:

Against Point No. 1

As per the notification/guidelines of the **Government of Odisha, Labour & ESI Department**, the category of **Security Guard** falls under the **Semi-Skilled** category & Gardener/Mali under Unskilled. Accordingly, bidders shall consider Security Guards as **Semi-Skilled** for the purpose of minimum wage calculation and submission of the financial bid or any other related purpose in the RFP documents.

Against Point No. 2


The Committee decided that registration under the **Odisha Shops & Establishments Act-1954**, as applicable, shall be accepted for the purpose of fulfilling the eligibility criteria.

Against Point No. 3


Regarding eligibility for participation in the tender, bidders are advised to refer to the provisions and eligibility criteria stipulated in the **Request for Proposal (RFP)** document.

With regard to the clarification requested on conditions 1.2.3. (B), it is to be mentioned here that the bidder should have executed at least three CFMS in the fields as mentioned in their referred point, during last three financial years as on 31.03.2025.


In addition, bidders who score **70% mark** or more shall be technically Qualified and shall be considered for financial evaluation, as per **OGFR -264 (iii)**




